

CUSTOMER AGREEMENT

This agreement, dated _____ is made by and between Rin Tin Inn Kennels, Inc.

(Company) and _____ (Customer).

The Parties hereby agree as follows:

1. Company agrees to provide dog kenneling and or doggie daycare services to Customer at Company's place of business. Services include outside/inside group playtime, feeding, cleaning, administering medication, etc. Customer is to supply the Company food to be fed to Customer's dog(s). Customer is to provide allergic information & dog food information to Company, prior to boarding and or daycare services. If Customer's dog(s) run out of supplied food, Company will buy food and be reimbursed by Customer. Customer is responsible for transporting Customer's dog(s) to and from Company's place of business.
2. Customer is aware that their dog(s) will be playing in a playgroup while boarding and or in doggie daycare. Please be aware that if your dog(s) play in a playgroup, your dog(s) are at risk of being injured. If Customer's dog(s) become injured, Company will provide vet care, if needed, and be reimbursed by Customer. If Customer's dog(s) cause an injury to another dog, Customer is responsible for other dog(s) vet bill. **If you do not wish to have your dog(s) in a playgroup, please advise Company prior to boarding and your dog(s) will have separate playtime.**
3. Customer represents that its dog(s) is/are healthy and free of contagious diseases, has/have received all vaccinations required by law and/or Company, and has/have been treated for fleas and other external and internal parasites prior to arrival to the kennel. Customer has supplied Company with proper vaccination records.
4. If Customer has not provided Company with the name and telephone number of at least one individual whom Customer has authorized to make emergency medical decisions regarding Customer's dog(s), or if Company is unable to contact the individual(s) after a good faith effort, Customer authorizes Company to make emergency medical decisions regarding Customer's dog(s). Customer acknowledges that it has provided Company with the name and telephone number of Customer's veterinarian. If Customer has not provided Company with their Veterinarian information, the Company will utilize the services of Company's affiliated veterinarian. Customer agrees to reimburse Company for all costs and expenses incurred by the Company.
5. Customer agrees to pay Company the following fees, to be paid in full when Customer picks up its dog(s) from Company (check lines that apply):

_____ Kenneling fee of \$28.00/day for the 1st dog, \$24.00/day for the 2nd dog and \$20.00/day for the 3rd and each additional dog. (Discounts apply for 7+ days)

_____ Doggie Day Care fee of \$20.00 per full day.

_____ Doggie Day Care fee of \$12.00 per ½ day.
